site in their Top 5 locations


Some regions in North America are going to be become flash points for workforce scarcity

Many companies have established alternative supply chains in the event of global tariffs

Most of the U.S. is running out of power

For every dollar of U.S. gross domestic product, at least 20% more logistic space is needed today

- Major geographic diversification underway from typical 'go-to' locations; lowest FDI in a generation
- More than 80% of site selection projects originating from Asia-Pacific are now considering a Mexico

Perfect storm across power utility markets


New demands on power capacity is unprecedented

Data center growth Crypto mining Automation deployment Advanced manufacturing industries Electric vehicle charging


- Seasonal impacts and natural disasters causing disruptions




Net Demand vs Net Generation


How do we address the power challenges? Prioritize, invest, and plan


- Businesses need to understand the long-term





The Great American Migration






Movement of Americans in 2020







Shifting Trends in Location Strategy Federal Funding Fiscal Cliff Coming

- Unprecedented federal funding provided for COVID recovery, relief, and economic stimulus are expiring at end of 2024
- Many states and communities leveraged these funds to support businesses through incentives, site / infrastructure investments, and workforce development
- Examples include California **Competes Grants and Florida Job Growth Grants**

ARPA State and Local Coronavirus Recovery Fund Funding Allocations through 2024



Shifting Trends in Location Strategy Incentives and Government Aid

- Additional funds to utilize from EDA and CDBG assistance
- More organized workforce training around specific ecosystems
- Incentives for retention of existing industry to allow for greater competition for internal investments




Shifting Trends in Location Strategy More Community Engagement




Volume of Goods Traded with United States (In USD)



First Street FSF Map – Risk Differential









